Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Driver Emil Toth was adjudged guilty of violating AGCO rules 22.05.01(a) (bear in causing interference) and (b) (impede the progress of another horse causing it to break) while driving ROSE RUN SLIDER (finished 3rd placed 9th) in the 10th race on 25 June and was assessed a driving suspension of five days (29-30 June & 1-3 July, inclusive) (SB 1029189).

Races:

- Jacques Beaudoin excused from five drives.
 - Pascal Berube excused from one drive
1. Late vet scratch (sick) by the AGCO veterinarian of #3 BAYWATCHING, refund: \$246. Inquiry and drivers objection by #6 TOWNSHIP GILLIGAN (Rodney LaFromboise) who finished 8th against #7 DE CHAIRMAN (Tyler Jones) after the start; #7 did bear down on #6 causing the horse to break (charted with an interference break); objection upheld, #7 finished 6th and was placed 8th (AGCO rule 22.09).

Mr. Jones was adjudged guilty of violating AGCO rule 22.05.01(a) (bear down causing a horse to break) and assessed a driving suspension of three days (30 June & 1-2 July, inclusive) (SB 1029202).

COOL HAND LUCAN (Richard Simard) suffered broken equipment (shoe) after the $\frac{3}{4}$ mile pole and finished 3rd with broken equipment. Clear.

2. Inquiry in the stretch concerning possible interference by #5 RACING FOR SPACE (Stephane Pouliot) who finished 4th against #7 ZEN DA BALLYKEEL (Tyler Jones) who finished 5th; although #5 did not maintain a straight course in the stretch Mr. Jones stated he was not bothered and his progress was not impeded; no violations.
