Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Backstretch:

The following information was relayed on yesterdays AGCO Seniors Report. It was realized after, that the dates stated were incorrect and the horses were made ineligible for fifteen days from July 2 to 16, 2020 and not from June 2 as stated in the report. Please accept my apologies for any confusion this may have caused.

Contacted Trainer William Tharrenos whose horse "Crafty Conquest" provided a positive analysis for the Class II drug, Capsiacin and Dihydrocapsaicin following the running of the fifth race on June 7, 2020, finishing second. "Crafty Conquest" has been made ineligible to race for fifteen days, June 2 through 16, 2020. *S/B July 2 through 16, 2020*

Mr. Tharrenos had a second horse "All Inclusive" provide a positive analysis for the Class II drug, Capsiacin following the running of the tenth race on June 7, 2020, finishing first. "All Inclusive is hereby ineligible to race for fifteen days, June 2 through 16, 2020. *S/B July 2 through 16, 2020*.

Contacted Trainer Michael DePaulo whose horse "Kid Forester" provided a positive analysis for the Class II drug, Capsiacin and Dihydrocapsaicin following the running of the fifth race on June 7, 2020, finishing second. "Kid Forester" is hereby ineligible to race for fifteen days, June 2 through 16, 2020. *S/B July 2 through 16, 2020*

Contacted Trainer Michael Mattine to inform him that his horse "Souper Hot" provided a positive analysis for the Class II drug Capsaicin and Dihyrocapsaicin following the running of the sixth race on June 11, 2020, at Woodbine finishing second. "Souper Hot" is hereby declared ineligible to race for a period of fifteen days July 3, through 17, 2020

Advised Jockey Larry Munoz of two rulings forwarded from Horse Racing Alberta Edmonton. Mr. Munoz relayed that the rulings are currently under appeal. I relayed we just received these and there was no mention of an appeal. Mr. Munoz was instructed to contact the Stewards at Century Downs then have them call us within the week. The rulings are outstanding since October 2019. **Film Reviews:**

Races:

Race 1 – Stewards Inquiry into an incident down the backstretch in the vicinity of the 5/8th pole involving #2 "Five Days In May" ridden by Isabelle Wenc. Isabelle's horse clipped the heels of #5 "Bossalina" ridden by Skye Chernetz, unseating Ms. Wenc in the process. Skye said she kept her mount straight and it was Isabelle that created her own situation. Isabelle said her horse was very strong and rank with her and was trying to get her back, did not want to be in that situation and maybe crossed out behind heels too quickly. Isabelle was attended by EMS who cleared her to ride. No Change was made.

Received a call from the Clerk of Scales, Alison Read, who relayed that Trainer Greg Cox called to advise his horse #3 "Cape Mist" slated to compete in the next race had lost a shoe. Was still at the barn with his blacksmith present, however, was unsure if they should fix the shoe in the barn or bring it to the Paddock blacksmith. We advised they shoe to be fixed prior to attending the Paddock.

Race 2 - #3 "Cape Mist" ridden by Emma-Jayne Wilson broke inward first jump.

Race 3 - #3 "Charles Street" ridden by Sahin Civaci broke hard to the outside and into #4 "Ghost Island" ridden by Rafael Hernandez and catching that ones heels.

Race 7 – Stewards Inquiry and Claim of foul by both Luis Contreras aboard #9 "Kuduro" and Keveh Nicholls aboard #5 "Love of Mine" against Jerome Lermyte aboard #6 "Dr. Green" for interference through the stretch. Jerome said his horse was getting in and he was using his crop left handed, did all he could and felt he was clear, much the best. Luis said he almost was put over the fence, Jerome came over on us very quickly, said Keveh Nicholls was pushed over onto him. Said Keveh was doing his best. Keveh Nichols said Jerome came over very fast intimidating his horse, was on his heels and had to check hard, never clear of me. After review, we Disqualified Jerome's horse from first and placed him ninth behind the horse of Contreras. AGCO rule II.07 - When clear, a horse may be taken to any part of the track, but if the horse swerves or is ridden to either side so as to interfere with, intimidate or impede any other horse, such horse may be disqualified.
