Race 2, #2 Sportscaster trailed early and was eased, rest ok.

Race 3, Turf, Jockey claim of foul, #2 Taravila, S. Singh, 3<sup>rd</sup> on #5 Sugar Me Sweet, J. Crawford, 2<sup>nd</sup>, in the vicinity of the 3/8. Upon review of back tower and upper pan camera angles, #5 is having some difficulty as he moves laterally inward and the #2 is there, #5, J.
