Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

- Phil Hudon excused from five drives this evening.
- Trainer Transfer approved on the horse YS Lallia from Rene Allard to Richard Moreau.
- Rick Zeron – \$200 monetary penalty and 3-day driving suspension (Aug 8-10) – did use more than acceptable wrist action while urging the horse Marzannk Hanover in Race 3 on July 27/20. AGCO Rules 22.23.03(b), Ruling #1046188.
- Sylvain Filion – 3-day driving suspension (Aug 5-7) – did change course and hook wheels while driving Matticulous GB in Race 10 on July 25/20. AGCO Rules 22.05.01(a)(h), Ruling #1046166
- Jonathan Drury – 3-day driving suspension – did change course and cause interference while driving East End in Race 7 on July 25/20. AGCO Rule 22.05.01(a), Ruling to follow.

Races

Race 1 – Inquiry – Reviewed the break by #1 Racing For Space (Doug McNair) before the start – horse was inside the Fair Start Pole, no violations.

Race 2 – Inquiry X 2/Driver’s Objection.

- Inquiry #1/Driver’s Objection – #10 Defcon Seelster (Guy Gagnon) on #6 Master Grand (Aaron Byron) at the half. Mr. Gagnon stated that #6 came down to him and pushed his wheel, which made him run up the back of #7 Greg (Steve Bryon). Mr. Byron stated he kept his path and did not move, as it was Gagnon that came out to him. The back tower video shows that #6 does remain in the same path and does not cause any interference. #10 created his own problem and was deemed at fault. Objection disallowed. #10 finished 6th and was placed 8th for causing interference to #7.

The front tower video shows #7 races inside one pylon; however, he is already past #1 Cool Princess (Curtis Clements) prior to going inside the pylon and did not gain an unfair advantage by going inside one pylon. No violations of the pylon rule by #7.
