IN THE MATTER OF THE *HORSE RACING LICENCE ACT, 2015*, S.O. 2015, c.38, Sched. 9; AND IN THE MATTER OF ROBERT KYLE FELLOWS

AGCO Standardbred Rules 9.09(b), 26.02.01, 26.02.02, 26.02.03(c) and Policy Directive No. 1-2018.

As the result of a Certificate of Positive Analysis (Tag # 53 23105 344) for the Class 3 drug Arsenic (Quantified at 458ng/ml) on the horse Warrawee Vital from Race 12 at Woodbine Mohawk Park on April 15, 2023.

Take Notice that Trainer Robert Kyle Fellows has accepted an AGCO settlement agreement with the AGCO Race Officials and is hereby issued a \$1,000 monetary penalty and 15-day full suspension, June 18 – July 2, 2023, Inclusive. Mr. Fellows must also complete the AGCO Equine Medication Use and Awareness program.

In accordance with AGCO Standardbred Rules 9.13 and 18.08.01, Warrawee Vital has been declared "disqualified" and all purse money and Driver/Trainer fees are to be returned for redistribution.

As per AGCO Rule 26.08, all horses trained, but not owned, by Robert Kyle Fellows may be transferred to the care of another trainer approved by the AGCO Race Officials.

The following terms are added to Fellows' license, as per Policy Directive No.3-2008, for a period of two years, July 3/23 – July 2/25, inclusive.

1. The Licensee shall keep the peace and be of good behaviour;

2. The Licensee shall allow Commission investigators access to his/her stabling area at any time to conduct unannounced random searches for illegal or non-therapeutic medications or drugs;

3. The Licensee shall allow Commission investigators to seize any illegal or nontherapeutic medications or drugs found at his/her stabling area; and 4. The Licensee shall be subject to the Commission's Out of Competition Program.5. The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed by the AGCO Race Officials for any breach of the terms of their licence.
