**Report on day's events:**

**Office:** Nothing to report.

**Races:**

**R1** – Recalled due to debris on the track. No Back Tower camera in this race due to vandalism, repairs are underway. Clear.

**R2** – Clear. #7 Winner Bells finished in 2:07 which does not meet the qualifying time for Western Fair Raceway. Trainer Cameron McQueen was notified.

**R3** – **INQUIRY** – Reviewed racing after the ¾ mile where #4 Wine Delight (N. Day) does pull out causing interference to #6 Maple Shadow (C. Kelly). After reviewing the video replay and speaking with the drivers, #4 who finished 2<sup>nd</sup> was placed 5<sup>th</sup>, behind #6. Also reviewed the pylons on #3 Halcyon Hanover (A. Sorrie, 3<sup>rd</sup>) after the ½ mile. No violation. Driver Natasha Day will be in to review the race with the Judges on Tuesday, December 3<sup>rd</sup>.

**R4** - #9 Hestonfreechips was removed from the mutuels early and was required to race as a non-betting interest. Clear.

**R5** – Clear. #6 Diamonds or Twine finished in 2:07 which does not meet the qualifying time for Western Fair Raceway. Trainer Garry MacDonald was notified.

**R6** – **INQUIRY** – Reviewed the breaks of #5 Spin for Life (Travis Henry, 4<sup>th</sup>). No violations.

**R7 – INQUIRY** - #8 Miramichi David (Tra Henry, 7<sup>th</sup>) had broken equipment before the start and was a pari-mutuel refund of \$1,349. This race was delayed by a flat tire on #1, and then a recall for a flat tire on #8. The rest was clear.

**R8** - #1 Lucy and Ethel (A. Sorrie, 8<sup>th</sup>) made a break after the start causing interference to most of the field and finishing with a missing shoe. The Judges reviewed the break and could not confirm where the horse lost the shoe. #1 was charted with a break and broken equipment (BE) at the finish.

**R9** - #6 Laa Dee Gaa (S. Fillion, 6<sup>th</sup>) made an extended break and must qualify for consecutive breaks on a fast track. Trainer Denis Julien was notified.

**R10** – Reviewed pylons after the ¼ mile on #5 Dinner and Dancing (A. Sorrie, 2<sup>nd</sup>). No violation.

**R11** – Clear.
