Report on day's events:

Office:

- In the third race TH CHA CHA CHA immigrated from the U.S. and the trainer elected not to race this horse on Lasix per AGCO rule 35.01 (EIPH Program Eligibility).
- Early Judges scratch (transportation) of TWICE THE DELIGHT (Cara Steacy trainer) from the third race.
- Early Judges scratch (retention) of PEFECT ROLO (Kelly Duval Lacaille trainer) from the seventh race; the explanation of Ms. Lacaille was accepted and no penalty was assigned relative to AGCO Standardbred rule 35.07 (Lasix administration).
- Review held with driver Melanie Plourde regarding her urging while driving BESTGIRL IN TOWN in the second race on 11 May; after reviewing the race video and discussing the urging rules and requirements an official warning was entered on the licence of the participant regarding AGCO rule 22.23.03(b) (more than acceptable wrist action).

Races:

- 1. Reviewed racing in the stretch; #2 TIA (Sebastien Turenne) and #5 WHISKEY FRIDAY (Robert Shepherd) hooked wheels in the stretch; as #2 was running out and #5 was running in fault was equally attributed with both horses charted with interference breaks; #6 GABBY SEELSTER (Marie-Claude Auger) was charted with interference; no change to the order of finish. The #7 KIKI DEE HANOVER (Pascal Berube) suffered broken equipment (flat tire) after the ¾ mile pole and was victorious with broken equipment. Clear.

- 4. Reviewed race pace of #4 EMMA TOWN BUD (Pierre Bovay) concerning the second quarter (27⁴ 59³ 127⁴ 156¹); Mr. Bovay was adjudged guilty of violating AGCO rule 22.05.01(k) (failure to set or maintain a pace comparable to class) and was assessed a \$100 monetary penalty (Number 3144988). Clear.
- 5. Reviewed breaks in the stretch by #8 CHIC CHOC ROSE (Marie-Claude Auger), who finished ninth, and #9 NORTHERN PROFESSOR (Guy Gagnon), who finished eighth; no change to the order of finish. Clear.

- 9. Reviewed the break by #3 SOUTHWIND RUSSIAN (Stephane Pouliot) after the start; while off stride #3 did cause interference to #6 WISHYOUDTELLME (William Roy); #3 finished seventh placed eighth (last) for an extended break (AGCO rule 22.27.02).

The #3 was not in position behind the gate when starter Jamie Fiolek released the field, in violation of AGCO rule 22.03(j)(vii); driver Stephane Pouliot was assessed a \$100 monetary penalty (Number 3145126).

Reviewed the break by #7 SENSI AMNESIA (Marie-Claude Auger) before the ¾ mile pole; while off stride #7 did cause interference to #2 GLOBAL MONI (Pierre Bovay), #5 JM STELLA (Sylvain Lacaille), #6 WISHYOUDTELLME (William Roy) and #8 STOMPER TOM (Ryan Guy); no placing necessary as #7 finished eighth (last). Clear.
