Race 1: Clear.

Race 2: #5 Cruisin On Bye post paraded with blinkers, was entered without blinkers. The equipment was removed at the gate. Trainer Bob Broadstock's explanation was accepted and no regulatory action required.

Steward's Inquiry & Jockey's Claim of Foul: After the break #1 Hours To Fly (Norman Lloyd DeSouza) came across the track and interfered with #2 Caraways Magic Rain (C.Benitez). Also, Jockey Claim of Fouls were lodged against #1 by #3 and #4, those were nullified as the inquiry

with #2 placed #1 Hours To Fly seventh (last). Norman Lloyd DeSouza will attend the Stewards' Office for film review.
