Trainer Gail Cox reported that her horse "Kokomo" slated to compete in todays seventh race would need to be scratched due to a stable error. Ms. Cox was issued a monetary penalty of \$300.00 for the error and necessitating a scratch. AGCO ruling # 3149354

Trainer Kevin Attard is issued a monetary penalty of \$500.00 and suspended three days May 25, 26 and 27, 2025 for a class IV positive analysis for the medication Meclofenamic acid (Arquel) submitted by his horse "Party On" following the running of the sixth race on April 26, 2025, at Woodbine. AGCO ruling #3150784

Race 2 – #4 "Told It All" ridden by Pietro Moran was away slow and then his lane closed.

Race 5 - #6 "Biles" ridden by Rafael Hernandez was unruly at the gate, unseated the rider and ran off. Scratched by the official veterinarian. Refund of mutuels \$77,976. Observed jockey Eswan Flores aboard #3 "Clearwater Beach" stand up prior to the finish. Eswan said he had to reduce hard today and this was his fifth race in a row, said he was cramping up coming the wire. Mr. Flores was issued a monetary penalty of \$200. for a first offence of failing to persevere with his mount throughout the race. AGCO ruling #3150958

Race 6 - #6 "Just Pray" ridden by Rafael Hernandez was unruly at the gate, unseated the rider and ran off. Scratched by the official veterinarian. Refund of mutuels \$76,651. Many unruly horses and broken equipment led to a total delay of the start by half an hour.

Race 9 – Stewards Inquiry and Jockey Claim of Foul by Leo Salles aboard #5 "Awsome Bourbon" against #6 "Society's Thunder" ridden by Jeffrey Alderson for interference during the stretch run. Leo said Jeffrey came down on top of Eswan aboard #7 "Junior Hot Shot" and me, it cost me a position and put both Eswan and me in a real bad spot. Jeffrey said his horse did drift in but he didn't hit him until he straightened him out, didn't think he bothered anyone. Eswan said his horse was dying but the outside horse came into his path and he had to check hard. After review, #6 was disqualified from first position and placed sixth behind #7.
