Backstretch:

Race Official Justin Stein is in training today

June 8th 2025 Race # 6 :

Reviewed incidents in both the backstretch and in the stretch between #5 "Biles" (Pietro MORAN) and #6 "Total Sensation" (Leo Salles)

Accepted Leo's explanation that it was his horse's first turf race, was green, switched leads and came in abruptly.

Pietro stated that his horse was drifting in during the stretch, running greenly.

Consensus that inexperienced horses was a contributing factor, and discussed need for jockeys to protect each other as much as possible. No further action to follow.

June 12th, 2025 Race # 7:

Reviewed incident (JCOF and Inquiry) in stretch between #1 "Artemus Citylimits" (Sahin Civaci) and #2 "Its Time to Shine" (Jose Campos) around the turn.

Accepted Jose's explanation that he was doing his best to correct the horse while bearing in. Video supports horse #1 bearing in significantly. No further action to follow

Jockey Sahin Civaci excused from his mounts today. Race 7,8,9.

R1: Clear

R2: Advised by Paddock Judge that #6 "Frac Right" would race with no hind shoes. Change announced to public / Displayed on TV Feed. #6 "Glorious Revenge" was eased through the wire. Rest Clear

R7: Jockey COF: #1 "Computer Hacker" Leo Salles (5th) on #7 "Stylish Gent" Jalon Samuel (1st) over racing exiting the chute, where racing gets tight along the rail with the #1 inside of #7. Jalon states that when he heard Leo yell, he straightened right out. Leo stated that Jalon came in on him, had to back out of his position. Video shows that #1 was briefly taken in hand but was not significantly impacted by the incident, and Jalon straightened out his mount quickly – Claim of foul disallowed.

R8: Jockey & Trainer COF: #2 "Canyouhearkerunning" Jose Campos (3rd) on #1 "Grainger County" – Juan Crawford (1st) near the 4 furlong marker Jose states that the #1 came over 1 – 2 paths causing him to clip heels. Juan states that he kept a straight course throughout. Back Tower feed shows that #1 kept a straight course from the gate through where the incident occurred. #2 ends up in behind #1 by approximately ½ path and clips heels and stumbles slightly. Determined to be inconclusive as to attributing fault – both Claims of Foul disallowed.

R10: Reviewed start of #10 "Jo Jagr" – Horse received fair start, dwelt. Rest clear.
