### Backstretch:

Race Official Justin Stein in training today.

Woodbine Entertainment Group released the following statement this morning.

On Thursday June 19, 2025, Woodbine Entertainment Group (WEG) confirmed that a horse sent to the University of Guelph on Tuesday June 17, 2025, tested positive for Equine Herpes Virus EHV-1. WEG is working closely with the HBPA, AGCO, and OMAFRA to ensure all protocols to protect equine welfare are adhered to.

The affected horse, in addition to, all remaining horses who were possibly exposed to the virus in the identified barn have been tested and are awaiting the results from the laboratory. Until such time, those horses will not be permitted to leave the barn and/or race.

Special bio security precautionary measures have been enacted to ensure any affected horse is isolated from the general horse population.

Woodbine Entertainment Group released a follow up report late this afternoon informing that 32 horses were tested and have returned a negative result.

Races 2, 4, 6 and 8 were removed from the inner turf, due to recent rains, and will run on the main Tapeta surface.

Race 1, Stewards' Inquiry and Jockey claim of foul, #1 Our Stella, A. Adams, 3<sup>rd</sup> on #2 Holymolymehmy, S. Chernetz, 1<sup>st</sup>, top of stretch. Upon review of upper pan, back tower and front tower camera angles, #1 is to the inside of #2 before the stretch run, room inside does diminish as #1 has to steady slightly, #2 has the clear advantage, the claim of foul was disallowed.

Race 2, Off Inner Turf, #2, Super Serenade, P. Moran bares out at the start making contact with #3, This Is Gloria, K. Nicholls, 2<sup>nd</sup>, no placings required, rest ok

Race 3, All clear

Race 4, Off Inner turf, Jockey and Trainer claim of foul, #9 Mrs. Hot Shot, Xarel Forde, 3<sup>rd</sup> on #4 Logistics, S. Civaci, 1<sup>st</sup> inside the 1/16 pole. Upon review of the upper pan and front tower camera angles, #4 does drift out slightly to #9, Mr. Forde does not appear to be impeded as he is still urging forward. Claim of fouls disallowed.
