Race 1, All clear

Race 2, All clear. Jockey Skye Chernetz excused from the remainder of her mounts today.

Race 3, Stewards' Inquiry and Trainer claim of foul, #1, J. Campos, 4<sup>th</sup> on #5, D. Moran approaching the finish, upon review of the front tower and upper pan camera angles, #1 and #5 are battling to the wire, #3 is inside takes a step out, is clear, #1 does steady a step. After review, the decision was no change to the order and trainer claim of foul disallowed.

Race 4, EPT Turf, #4 Moet Monet, A. Vandermeersch, 9<sup>th</sup>, a little erratic through run down backstretch, was steadied a few times, rest ok.

Race 5, Inner Turf, #3 Lemon Sweets was eased from the middle of the turn, rest ok

Race 6, All clear

Race 7, Greenwood Stakes, Jockey claim of foul, #5, It Ain't Two, E. Flores, 2<sup>nd</sup> on #6, Love Cervere, E. Cancel, 1<sup>st</sup>, run down the backstretch, upon review of the back tower camera angle, #6 is outside and moving slightly inside, #5 is to the inside of that one, but the #2, P. Moran, 6<sup>th</sup>, is having difficulty and pushes #5 out. #6 was not at fault, Claim of foul disallowed.

Race 11, 2 Inquiries,

#1, Stewards' Inquiry, Jockey claim of foul, #1, #8, A. Adams, 5<sup>th</sup>, on #12, S. Vives, 3<sup>rd</sup>, far turn, upon review of back tower and apex camera angles, #12 is making its move as you can see #8 does clip a heel, inconclusive as to the incident as we could not determine if the inside pushed out, disallowed,

Inquiry #2, Stewards Inquiry Jockey claim of foul, #5, S Civaci, 4<sup>th</sup> on #12, S. Vives, 3<sup>rd</sup>, stretch run, upon review of the upper pan and front tower, the #12 veers out and impedes #6, D. Moran and #5, S. Civaci. It was decided #12 be placed from 3<sup>rd</sup> to 8<sup>th</sup> position behind #6. Notice of review for those riders involved tomorrow.
