June 21st – Race 11:

Reviewed racing in the stretch run with Jockeys David Moran (#6, 7th), Sofia Vives (#12, 3rd) and Sahin Civac (#5, 4th) - There was a claim of foul (#5 on #12, and a subsequent placing) Video shows a chain reaction whereby Ms. Vives mount swerves outwards after left-handed urging, bumping Mr. Moran's mount, who then pushes Mr. Civaci's mount outwards. Ms. Vives assessed 3-day riding suspension for Interference – days to be determined.

June 22nd – Race 5: Reviewed racing shortly after the break. There was a Stewards' Inquiry and a Jockey claim of foul by Ryan Munger (#5, 5th) on Rafael Hernandez (#6, 4th), which resulted in a placing. Video shows #6 bears in into the path of #5, causing Mr. Munger's mount to clip heels and stumble.

Mr. Hernandez assessed a 3-day riding suspension for Interference – Days to be determined.
