Olaf said he was in front and had a length to a length and a half on the inside horses, don't know why she was yelling. Leo said the outside horse came over and bumped him into the inside horse. After review, #6 was disqualified from second and placed fourth behind #1. The COF was upheld. After the race was official, it was realized the doors of the #7 "Brienne of Tarth" with Christopher Husbands opened early. The horse finished fifth and was placed sixth, which turns out to be last.
