Ruling Number SB ADMIN 46/2019

TORONTO, ONTARIO – December 24, 2019

**IN THE MATTER OF THE HORSE RACING LICENCE ACT, 2015;  
S.O. 2015, c.38, Sched. 9;  
AND IN THE MATTER OF ANDREW MCCABE, LICENCE NO. Y09178**

On October 29, 2019, the standardbred horse "CRAZY LUKE DUKE" (freeze brand # 4PM56) finished second (2<sup>nd</sup>) in the eighth (8<sup>th</sup>) race at Western Fair Raceway. CRAZY LUKE DUKE is trained by ANDREW MCCABE "MCCABE".

On October 31, 2019 Racing Forensics Inc. reported that the blood sample with Test Tag number 491930215, contained TC02 with a value measured of 39.7 mmol/L.

**TAKE NOTICE** that based on the above MCCABE is found to have violated 22.38(a), 26.02.01, 26.02.02 and 26.02.03 (d) of the Rules of Standardbred Racing.

Accordingly, pursuant to the authority under 6.01, 6.04, 9.08.02 and 22.38.06 of the Rules of Standardbred Racing and Policy Directive 1-2018, MCCABE is hereby fully suspended for **FOURTY-FIVE (45) days** (December 24, 2019 to February 6, 2020, inclusive) and issued a monetary penalty of two thousand five hundred dollars (\$2,500).

In accordance with Alcohol, Gaming and Racing Standardbred Rule 18.08.01, CRAZY LUKE DUKE is hereby declared disqualified for all purposes, with the exception of Pari-Mutuel Wagering. Purse money to be returned for re-distribution. The revised order of finish for Race 8<sup>th</sup> at Western Fair Raceway on October 29, 2019 is as follows:

CRAZY LUKE DUKE - disqualified  
BIG BOY FRAZIER - disqualified

The following terms are added to MCCABE's license: two years of probation commencing (February 7, 2020 to February 6, 2022, inclusive), pursuant to Rule 6.01 (d) of the Rules of Standardbred Racing and Policy Directive No. 3-2008:

1. The Licensee shall keep the peace and be of good behaviour;
2. The Licensee shall allow Commission Inspectors access to his stabling area at any time to conduct unannounced random searches for illegal or non-therapeutic medications or drugs;
3. The Licensee shall allow commission inspectors to seize any illegal or non-therapeutic medications or drugs found at his stabling area;
4. The Licensee shall be subjected to the AGCO's Out of Competition Program; and
5. The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed by the AGCO Racing Officials for any breach of the terms of their license.
