## IN THE MATTER OF THE HORSE RACING LICENCE ACT, 2015, S.O. 2015, c.38, Sched. 9; AND IN THE MATTER OF BOBBIE JO WEINHOLDT WEINHOLDT HARRIS

On October 2, 2021, the standardbred horse "FACE OF WAR" (tattoo number 8M644) finished fifth (5th) in the sixth (6th) race at Flamboro Downs Raceway. "FACE OF WAR" is trained by Bobbi Jo Weinholdt Harris "WEINHOLDT HARRIS".

On October 4, 2021, Racing Forensics Inc. reported that the blood sample with Test Tag number 332127512, contained TC02 with a value measured at 37.5 mmol/L.

**TAKE NOTICE** that based on the above WEINHOLDT HARRIS is found to have violated 22.38 (a), 26.02.01, 26.02.02 and 26.02.03 (d) of the Rules of Standardbred Racing.

Accordingly, in accordance with Rules 6.01, 6.04, 9.08.2, 22.38.06 of the Rules of Standardbred Racing ("Rules"), and Policy Directive 1-2018, WEINHOLDT HARRIS is hereby fully suspended for FORTY-FIVE days (45) (January 26, 2022 to March 11, 2022, inclusive) and issued a monetary penalty of two thousand five hundred (\$2,500) dollars.

TAKE NOTICE that all horses owned in whole or in part are suspended and are not eligible to race during the suspension period. All horses may with the consent of the AGCO Racing Officials be released to another trainer in accordance with Rules 6.13.01 and 26.08. All purse monies shall be returned for redistribution. In accordance with Rules 9.13 and 18.08.01, "FACE OF WAR" is hereby declared unplaced for all purposes, with the exception of Pari-Mutuel Wagering. The revised order of finish for Race 6 at Flamboro Downs Raceway on October 2, 2021 is as follows:

## #4 FACE OF WAR - disqualified

The following terms are added to WEINHOLDT HARRIS' license: two years of probation commencing (March 12, 2022 to March 11, 2024, inclusive), pursuant to Rule 6.01 (d) of the Rules of Standardbred Racing and Policy Directive No. 3-2008.

1. The Licensee is required to complete the AGCO Equine Medication Use and Awareness Program before reinstatement;

2. The Licensee shall keep the peace and be of good behaviour;

3. The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed by the AGCO Judges for any breach of the terms of their license.
