**IN THE MATTER OF THE *HORSE RACING LICENCE ACT, 2015*,  
S.O. 2015, c.38, Sched. 9;  
AND IN THE MATTER OF Catherine M Day Phillips**

On October 6, 2020, Bureau Veritas Canada issued a certificate of positive analysis, from a blood sample, test tag #73 20269 366, for the Class III medication Acepromazine and its metabolite 2-(1-Hydroxyethyl) Promazine. The sample was obtained from the horse, "Barilko", owned by Anderson Farms Ontario Inc., George P. Ledson & Scott Kelly and trained by Catherine DAY PHILLIPS, which finished first in the ninth race at Woodbine racetrack on September 25, 2020.

TAKE NOTICE that Trainer Catherine DAY PHILLIPS, having accepted the settlement agreement, is hereby issued a suspension of fifteen calendar days, November 9 through 23, 2020, and a monetary penalty in the amount of \$1,000.00, payable at the termination of the suspension. The suspension of Ms. DAY PHILLIPS is effective for horses racing in The Province of Ontario and during the suspension is denied access to any Association grounds with the exception of grandstand privileges. Any horses that are to be entered to race or trained by Ms. DAY PHILLIPS during the suspension, must be transferred to another trainer in good standing and approved by the Stewards. In accordance with AGCO TB Rule 15.04.03, the horse "Barilko" is hereby unplaced from the ninth race at Woodbine on September 25, 2020 for all purposes with the exception of pari-mutuel wagering.

The revised order of finish shall be as follows:

- 1<sup>st</sup> - Sunspear
- 2<sup>nd</sup> - Risetothethechallenge
- 3<sup>rd</sup> – Mister Oakley
- 4<sup>th</sup> – First Crusader
- 5<sup>th</sup> – Forehead Fred
- 6<sup>th</sup> – Conquer Him
- 7<sup>th</sup> – Patrol

Pursuant to Policy Directive 3 - 2008, Catherine DAY PHILLIPS has the following conditions placed on her license for a period of two years, November 24, 2020 through November 24, 2022.

1. The licensee shall keep the peace and be of good behaviour.
2. The licensee shall allow AGCO Compliance Officials access to her stabling areas at any time to conduct unannounced random inspections.
3. The licensee shall allow AGCO Compliance Officials to seize any items of concern to the best interests of racing.
4. The licensee shall be subject to the AGCO out of competition testing program.
5. The licensee may be subject to a Notice of Proposed order in addition to any penalty imposed by AGCO Racing Officials for any breach of the terms listed.
