## **Races**

Race 1. Dustylane Sam (Moore) pulled up past the half. The Vet did examine the horse and was found to have an irregular heartbeat. Vet short term and Judges list.

Race 2 Reviewed the break at the start by #5 Captain Godro (Moore), no violations.

Race 3 Inquiry at the start. #2 Top of The Bar and #5 All R Wishes made breaks, #5 was not inside the fair start pole and was refunded (\$989). Also reviewed the breaks in the 2<sup>nd</sup> quarter on #2 and #3 Out on A Mission, no breaking rule violations.

Race 4 Justalittlebetter finished distanced and must qualify.

Race 5 Clear

Race 6 Clear

Race 7 Reviewed pylons in the last turn by #1 Artistic Meadow (Trevor Henry), the wheel was inside 1 pylon and over 2 pylons. No violations.

Race 8 Reviewed the break on #6 Hope So after the start. The horse was off stride for more than 25 consecutive strides but did finish last, no placing needed. AGCO rule 22.27.02 If a horse is not on its proper gait, in a race, for 25 consecutive strides or more (extended break) after the horse's nose has crossed the start line, that horse shall be placed last. However, the Judges may, in their discretion, determine not to set the horse back if interference caused by another driver(s) or horse(s) has caused the horse to be on a break for 25 consecutive strides or more.

Race 9 Inquiry in the stretch. #3 Charmbo Princess (Saftic) made a break, did not violate any breaking rules. The horse finished 4<sup>th</sup> and there will be no placing needed. Also reviewed the break by #6 Rubys are Nice (McNair) finished 6<sup>th</sup> and was placed 7<sup>th</sup> for being off stride for more than 25 consecutive strides (22.27.02).

Race 10 Reviewed the break in the first turn by #7 Sweet Pink (Drury). No violations.

Race 11 Reviewed the break in the first turn by #1 Witnessintheshadow (Richardson). The horse suffered an equipment break and pulled up with a broken hopple. Trailing horses 2,4,7,8 were charted with interference.
