

Report on day's events:

Office:

- 3 Eliminations for the Kin Pace (3YO Filly Pacers) and 2 Divisions of the Prospect Series for 3YO Colt and Gelding Pacers this afternoon.

- Ruling for Doug McNair at Mohawk Saturday night, Race 10 – \$300 monetary penalty for AGCO Rule 22.19. Ruling #1239829.

- Judges spoke with Trainer David O'Brien regarding purse money that needs to be returned.

- No Qualifiers or Schoolers this afternoon.

Races:

Race 1 – Reviewed racing going to the quarter – the leader #1 Dirty Beach (Colin Kelly) slows up on the front; no violations or placings needed.

- #6 Spirit Of A Storm (Doug McNair) was a late vet scratch due to lameness. Refund \$822

Race 2 – All Clear

Race 3 – All Clear

Race 4 – Inquiry X2 at the start and first turn.

- Inquiry #1 – Reviewed the first turn and a possible break/pylon violation by #1 Life Is Better (Natasha Day), finished 3rd. The video shows that #1 is inside three consecutive pylons and makes a quick break. Ms. Day stated she was forced inside the pylons by #4 Crankys Boy (Austin Sorrie). Mr. Sorrie stated his horse was hooked on the left line and crossed over sharply on #1. The video supports that #4 causes interference and forces #1 inside the pylons for safety reasons and to make a break. #1 was charted with an 'ix'. No placings were necessary as #1 finished ahead of #4.

- Inquiry #2 – Reviewed the start – #2 Larjon Lucky (Tyler Moore) makes a break before the start and causes interference to #8 Acefortyfourtalon (Brett MacDonald). #8 refunded (\$444) for suffering interference before the start.

- Starter Brad Pittock said it was too late for a Recall as he was committed to the start and opening the wings when the incident happened.

Race 5 – All Clear

Race 6 – Reviewed racing past the quarter – #4 Country Boy Tough (Natasha Day) gets rough but does not make a break. Finished 2nd.

- Reviewed racing in the first turn – #1 Smilingbillythekid (George Ketros) was inside one pylon, no violations. #3 Editorial (Travis Henry) was charted with interference from #1 coming out of the pylon. Judges spoke to Ketros about having more control of his horse.

Race 7 – All Clear

Race 8 – All Clear

- #2 Village Jade (Phil Hudon) finished distanced and must qualify for Performance. The horse was placed on the short-term Vet's list (sick) by Association Vet Dr. Chris Robson.

Race 9 – Reviewed pylons on #1 Watt Machs Me Win (Bruce Richardson) in the first turn, finished 2^{nd} – inside one pylon, no violations.

Race 10 - Reviewed pylons on #3 Jackieofalltrades (Robert Shepherd) after the half, finished 1^{st} – inside one pylon, no violations.

- #4 Treasures Gem (Ryan Desroche) finished distanced and must qualify for Performance.

Race 11 – Inquiry – Reviewed racing at the 5/8ths – #8 Hard Rock (Jody Jamieson) gets rough but does not make a break. There was no interference caused by #4 Dabunka (James MacDonald). No violations.
