## IN THE MATTER OF THE HORSE RACING LICENCE ACT, 2015. S.O. 2015, c.38, Sched. 9; AND IN THE MATTER OF Joseph C Currie

On March 17, 2021, the Alcohol and Gaming Commission of Ontario "AGCO" was advised of a positive reading for the Class 5 drug furosemide, for the urine sample with Test Tag 53 21064 302 E. The sample was obtained from the Standardbred Horse "PICKLES ON TOP" (tattoo #6MR04), which finished first (1st), in the first race (1st) race, on March 5, 2021 at Mohawk Raceway. PICKLES ON TOP is trained by Joseph Currie (Licence #HPE2031) ("CURRIE"):

**TAKE NOTICE** that based on the above CURRIE is found to have violated 9.09 (b), 26.02.01, 26.02.02 and 26.02.03(c) of the Rules of Standardbred Racing.

**AND TAKE NOTICE** in accordance with 6.04, 9.08.02 of the Rules of Standardbred Racing and Policy Directive 1-2018, and having consideration for an error made during the sample collection process;

CURRIE is hereby given no suspension or monetary penalty;

In accordance with 9.13, 18.08.01 and 18.08.03 of the Rules of Standardbred Racing, and Policy Directive No. 1-2018, PICKLES ON TOP is hereby declared disqualified for all purposes with the exception of Pari-Mutuel Wagering and all purse money and driver/trainer fees earned by PICKLES ON TOP shall be returned and redistributed.
