## IN THE MATTER OF THE HORSE RACING LICENCE ACT, 2015, S.O. 2015, c.38, Sched. 9; AND IN THE MATTER OF DANY FONTAINE

On December 12, 2022, the Alcohol and Gaming Commission of Ontario "AGCO" was advised of a positive reading for the Class 2 drug selegiline, in the blood sample Test Tag 33 22331 302. The sample was obtained from the Standardbred horse, "TITANIUM ALPHA", (tattoo #0TN39), which finished second (2nd), in the second (2nd) race on November 27, 2022, at Flamboro Downs Raceway. TITANIUM ALPHA was trained by Dany FONTAINE "FONTAINE".

TAKE NOTICE that based on the above FONTAINE is found to have violated 9.09(b), 26.02.01, 26.02.02 and 26.02.03(c) of the Rules of Standardbred Racing. In accordance with 4.02(i), 6.04, 9.08.02 of the Rules of Standardbred Racing and Policy Directive 1-2018, FONTAINE is hereby fully suspended for one year, (April 27, 2023 to April 26, 2024, inclusive) and issued a monetary penalty of TEN THOUSAND dollars (\$10,000.00).

TAKE NOTICE that all horses owned in whole or in part are suspended and are not eligible to race during the suspension period. All horses may with the consent of the AGCO Racing Officials be released to another trainer in accordance with Rules 6.13.01 and 26.08. All purse monies shall be returned for redistribution. In accordance with Rules 9.13 and 18.08.01, TITANIUM ALPHA is hereby declared disqualified for all purposes with the exception of Pari-Mutuel Wagering and all purse monies must be returned. The revised order of finish for Race 2, at Flamboro Downs Raceway on November 27, 2022 is as follows:

The following terms are added to FONTAINE's license: two years of probation commencing (April 27, 2024 to April 26, 2026, inclusive), pursuant to 6.04 of the Rules of Standardbred Racing and Policy Directive No. 3-2008:

- 1. The Licensee is required to complete the AGCO Equine Medication Use and Awareness Program before reinstatement;
- 2. The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed by the AGCO Race Officials for any breach of the terms of their license.
