

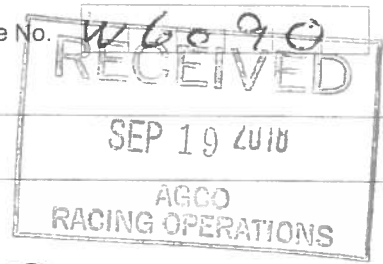

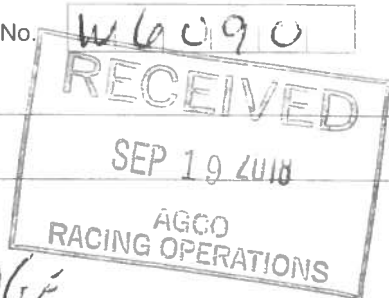

**Policy DIRECTIVE 3-2008**

- 1) THE LICENSEE SHALL KEEP THE PEACE AND BE OF GOOD BEHAVIOR
- 2) THE LICENSEE SHALL ALLOW COMMISSION INSPECTORS ACCESS TO HIS STABLING AREA AT ANY TIME TO CONDUCT UNANNOUNCED RANDOM SEARCHES FOR ILLEGAL OR NON-THERAPEUTIC MEDICATIONS OR DRUGS.
- 3) THE LICENSEE SHALL ALLOW COMMISSION INSPECTORS TO SEIZE ANY ILLEGAL OR NON-THERAPEUTIC MEDICINES OR DRUGS FOUND AT HIS STABLING AREA.
- 4) THE LICENSEE SHALL BE SUBJECT TO THE COMMISSIONS OUT OF COMPETITION PROGRAM
- 5) THE LICENSEE MAY BE SUBJECT TO A NOTICE OF PROPOSED ORDER IN ADDITION TO ANY PENALTY IMPOSED BY THE JUDGES FOR BREACH OF THE TERMS OF HIS LICENSE.
