

# Integrity, Safety, and the Public **Interest in Ontario Horse Racing**



### EQUINE WELFARE

FEEDBACK: Ensure welfare is protected throughout the life cycle of a racehorse and ensure rules and policies are made with equine welfare in mind.



### PARTICIPANT SAFETY FOR JOCKEYS AND DRIVERS

FEEDBACK: Increase overall health of particip by establishing concuss protocols, increasing joc weights, and formalizing safety standards.



### **RACETRACK MAINTENANCE AND OPERATIONS**

FEEDBACK: Develop maintenance standards to ensure race paddocks, backstretches, and race surfaces are safe for all participants.

FEEDBACK: Improve communication and information sharing. Simplify the rules and enhance industry education.

## Here's What You Said On: Reducing the Administrative Burden and Removing Unnecessary Barriers



#### LICENSING MODERNIZATION

**FEEDBACK:** Move to online licensing, with the option to purchase a multi-year or multibreed licence. Ensure services for licensing at the racetracks remain for those who do not have computer access.



#### LICENSING REQUIREMENTS

**FEEDBACK:** Review licensing fees, and determine which industry participants need to be licensed by the AGCO. Attempt to streamline licensing operations with other racing jurisdictions.



#### LICENSING FRACTIONAL OWNERSHIP

**FEEDBACK:** Clarify and simplify licensing requirements for fractional owners. Increase the percentage required to be licensed as a fractional owner.

#### OFFICIATING AND TECHNOLOGICAL ENHANCEMENTS

**FEEDBACK:** Improve consistency and transparency in officiating, through enhanced communications from Race Officials, Race Official training programs, and enhanced video technology used to review races.

## RACE OFFICIAL REVIEW PROCESS AND APPEALS

**FEEDBACK:** Simplify Race Official review process and communication processes from Race Officials.



# Supporting Economic Development and Industry Innovation



#### **PUBLIC PERCEPTION**

**FEEDBACK:** Economic stability is only possible if the industry and the AGCO are able to ensure the public that racehorses and participants are treated humanely and fairly. The public would likely not support an industry that is not taking action to prevent substandard racehorse care.



### INDUSTRY ENGAGEMENT ON RULE CHANGES

**FEEDBACK:** The industry should be included in future rule changes through a more formalized process. Rule changes should aim to simplify and clarify rules, and protect equine welfare.




