Race 1 – Reviewed the break by #4 Proberts Legacy (Travis Henry) in the first quarter – #5 Choreographer (Daryl Thiessen) and #8 Toot Toot N (Ed Hensley) were charted with interference; no placing needed.

Race 2 – Reviewed the break by #3 Elroy Shiner (Paul MacKenzie) in the third quarter – #4 Dance Machine (Austin Sorrie) was charted with interference; no placing needed.

Race 3 - All Clear

Race 4 – Reviewed the break by #4 Lobel Bruiser (Travis Henry) around the final turn, finished 5th – no violations of the breaking rule.

Mr. Kelly stated the horse races better following along on the inside and felt if he pulled to follow the cover of #2 Shades Of Bay (Jody Jamieson) that he would likely go backwards. Also, #2 is a horse that has a history of bearing out and staying along the pylons to save ground was a better strategy. The horse got clearance in the stretch and was unable to advance, finished 7th. Mr. Kelly's explanation was accepted as the horse was unable to keep the two-hole closed going to the quarter. Furthermore, the past performances do not indicate the horse has a history of advancing when moved to the outside.
