- The Panel of Race Officials Stewart, Lawrence and Fines held a Review with Trainer Shawn Steacy on Tuesday regarding a Certificate of Positive Analysis for the Class 3 Drug Lamotrigine on the horse Dance With Tabby from Race 7 at Woodbine Mohawk Park on April 7/23. Mr. Steacy has accepted an AGCO settlement agreement and been issued a \$1,000 monetary penalty and 15-day full suspension, May 21 – June 4/23, inclusive. Steacy must complete the AGCO Medication and Awareness program and has terms added to his license for a period of two years, June 5/23 – June 4/25, as per Policy Directive No.3-2008. AGCO Rules 9.09(b), 26.02.01, 26.02.02, 26.02.03(c), Policy Directive No.1-2018, 9.13, 18.08.01, and 26.08. Ruling #2179046.
