- Ron Burke – \$200 monetary penalty – did make a late driver change on the horse Birthday in Race 10. AGCO Rule 17.19, Ruling #2182580.

### RACES

Race 1 – Reviewed pylons on #4 Busting With Pride (James Macdonald) around the final turn, finished 2<sup>nd</sup> – #4 raced inside one pylon; no violations of the AGCO pylon rule.

- #2 Eternally Hanover (LP Roy) finished 7<sup>th</sup> placed 8<sup>th</sup> for an extended break.

Race 2 – #2 Sunset Epona (Pat Hudon) finished 6<sup>th</sup> placed 7<sup>th</sup> for a lapped-on break.

- #9 Amber Ornament (JB Renaud) suffered an equipment break (hopples) in the second quarter and pulled up after the half.

Race 3 – Inquiry X 3

- Inquiry #1 – Reviewed pylons on #5 Kinnder Thinktwice (LP Roy) at the top of the stretch, finished 2<sup>nd</sup> – #5 raced inside one pylon; no violations of the AGCO pylon rule.

- Inquiry #2 – Reviewed pylons on #1 He Will (Scott Coulter) and #7 Wolinak (Trevor Henry) at the 5/8ths – both #1 and #4 were inside one pylon around the turn, but never inside two consecutive pylons. No violations of the AGCO pylon rule by #1 and #7.

- Inquiry #3 – Reviewed the break by #1 He Will (Scott Coulter) in the first turn, finished 4<sup>th</sup> – #1 went inside the pylons while on a break for safety purposes and re-entered the racecourse when he had clearance to do so. The Panel ruled #1 failed to continuously lose ground while off stride and therefore was 4<sup>th</sup> placed 5<sup>th</sup>.

- #1 finished with broken equipment (shoe).

Race 4 – All Clear

Race 5 – Reviewed pylons on #8 Rough Tuff Tested (James Macdonald) at the 5/8ths, finished 2<sup>nd</sup> – #8 raced inside one pylon; no violations of the AGCO pylon rule.

- Reviewed pylons on #2 Floyd The Freak (Ed Hensley) in the first turn, finished 1<sup>st</sup> – #2 hits two pylons and is not inside any pylons; no violations of the AGCO pylon rule.

- Reviewed the break by #5 Devils Arch (Jody Jamieson) in the first turn, finished 5<sup>th</sup> – #5 was ruled off stride for 23 strides. No violations of the AGCO breaking rule.

Race 6 – Reviewed racing at the 3/8ths – #5 The Fixer (Doug McNair) has clearance to move off the rail; no interference to #6 Esquire (Tyler Borth).

Race 7 – All Clear

Race 8 – All Clear

Race 9 – Inquiry – Break by #1 Sayonara Royalty (Trevor Henry) before the start – not inside the Fair Start Pole, Refund \$5,537. No Inquiry tape available as #1 was too far back and not on video.

Race 10 – Inquiry – Reviewed racing going to the quarter between #2 Roll With The Flow (Bob McClure), #5 Birthday (Yannick Gingras) and #10 Ron (Phil Hudon). #10 is racing first-over between horses going to the quarter when Hudon takes a hold of his horse to get into a hole. In doing so, #10 backs into #5 and forces that horse three-wide. #10 does not have clearance to move down to the rail between #9 Layton Hanover (Jody Jamieson) and #2, which causes McClure to take a hold of his horse when #10 drops down in front of him. #10 was ruled to have caused interference and confusion to both #2 and #5. #10 finished 5<sup>th</sup> placed 7<sup>th</sup>.

Race 11 – Inquiry – Break by #8 My Holy Moley (Jody Jamieson) before the start – not inside the Fair Start Pole, Refund \$2,667.
