Race 3 – Inquiry – Reviewed the break by #3 Skylee Dream (Sylvain Lacaille) at the start, finished 4th – no violation of the AGCO breaking rule by #3.

Race 4 – Reviewed the breaks by #1 Run Like Hill (Colin Kelly), #5 Ricky Resolve (Brett Macdonald) and #6 Cascada (Travis Cullen) at various points during the race. The only placing required for an extended break was #1 – finished 5th placed 7th.

Race 5 – Inquiry – Reviewed racing in the stretch between #3 Sweet Money Honey (Doug Chappell) and #4 Angel Of My Dreams (Travis Henry). Mr. Henry stated his horse was running in on him and not bothered by #3. The pan video shows that there was no interference caused by #3. No change.

Race 6 – Inquiry X 2

- Inquiry #1 – Reviewed the break by #8 Hello Rocky (Brett Macdonald) in the stretch, finished 2nd – no violations of the AGCO breaking rule by #8. #8 was charted with an 'ix' as it appears he shies away from the broken head pole laying on the track.

- Inquiry #2 – Reviewed the start on #9 Land Of Royalty (Travis Henry). The pan video shows #9 suffers broken equipment (head pole) before the start. Refund \$6,430.

- A claim entered on #4 Freddy Bear was first submitted incorrectly as per AGCO Rule 15.11(c). Once corrected, the claim was late (24 MTP) and therefore voided as per AGCO Rule 15.11(d).

Race 7 – Reviewed the breaks by #1 Home From Away (Paul MacKenzie), #2 Handsome Hank (Tyler Moore) and #5 Louise Trapeze (JB Renaud) at various points during the race. All horses were inside the Fair Start Pole and following the AGCO breaking regulations.

Race 8 – Inquiry – Reviewed pylons on #3 Kickin Your Mass (Anthony Haughan) in the first turn, finished 3rd – the pan video shows #3 is inside one pylon and hits two other pylons. No violations of the AGCO pylon rule by #3.

- #9 Laugh Now (Travis Henry) was charted with an equipment break (hopples) in the stretch.

Race 9 – OSS Gold for 2YO Colt and Gelding Pacers.

- Inquiry – Reviewed the break by #3 Write Me A Rose (Sylvain Filion) at the top of the stretch, finished 4th. The Panel ruled that the break by #3 caused interference to #4 Whatchulookin At (Doug McNair), who in turn interfered with #7 Winmebak (James MacDonald) by forcing MacDonald to check his horse and go inside the pylon leading into the passing lane. As a result, #4 and #7 were charted with interference and #3 finished 4th placed 5th for causing interference while on a break (behind #7 as per AGCO Rule 22.09).

Race 10 – Inquiry – Reviewed pylons on #3 Halo Its Heaven (Scott Young) at the 5/8ths, finished 2nd – The pan video shows #3 is inside one pylon and inconclusive on whether inside a second pylon. The #3 was also being forced down by #1 Kiss My Mass (Bob McClure). No violations or placings needed.
