RACES

Race 1 – All Clear

Race 2 – All Clear

Race 3 – #7 Barrys Shelby (Aaron Byron) was charted with interference due to the break by #4 Always Been Crazy (Preston Shaw) after the half. No placings needed.

Race 4 – Recall – BE on #2 F Three Fifty (Ryan Desroche). Race All Clear.

Race 5 – Reviewed pylons on #2 Tojenniferscredit (Travis Cullen) at the top of the stretch, finished 5th – #2 races inside one pylon, did not gain an unfair advantage – no violations of the AGCO pylon rule.

Race 6 – Inquiry – Reviewed racing at the top of the stretch between #6 Silverback Jack (Colin Kelly) and #7 Three Somewhere (Austin Sorrie). The pan and front tower video shows that #6 drifts out and into the path of #7, catching the back leg of #7. As a result, #6

finished 3rd placed 6th for interference. #3 Indigenous Hanover (J Bradley Harris) was also charted with interference. Video will be sent to Kelly for a Review.

Race 7 – Inquiry – Break by #3 Peetie (Daryl Thiessen) before the start – not inside the Fair Start Pole, Refund \$14,560. Horse was too far back, no inquiry video available.

- Reviewed racing at the 3/4s – #6 Shout It Out Loud (Paul MacKenzie) was charted with interference due to #1 Fear The Captain (Pat Hudon). No placings needed.

Race 8 – Inquiry – Reviewed the start of #2 Chesusmurphyjoesph (Colin Kelly) – not inside the Fair Start Pole, Refund \$10,909. Horse was too far back, no inquiry video available. #2 pulled up after the half, must qualify for Performance. Dr. Pat Myers examined the horse following the race and found nothing abnormal with the horse.
