### STAND

- The following rulings were generated from the Panel of Race Officials Stewart, Minler and Stiff from a Review with Drew Neill on September 9. An AGCO Compliance Official did an inspection of Mr. Neill's stable area on June 16/21 and found Neill in possession of a cattle prod.

- Ruling #1342771 – \$1,000 monetary penalty and six-month full suspension (October 13, 2021 – April 12, 2022, Inclusive). Mr. Neill also had terms added to his license for a one-year period (March 7, 2023 – March 6, 2024) as per Standardbred Directive No. 3-2008. AGCO Rules 6.04 and 22.21 apply.
- Ruling #1342744 – \$1,000 monetary penalty for a breach of probation terms in SB Ruling #1111336.

- Nick Stewart excused from two drives.
