Received telephone calls from Trainer Amanda Fines and Bill O'Donnell of COSA inquiring why the horse "Highland Sunseeker" did not get in for Sundays draw. Informed both to call Race Secretary Sheri Minler-Grabatin in the morning.

Meeting/Hearing with trainer Kevin McMaster held at Mohawk Raceway Tuesday March 23rd at 12:00 pm regarding his 2 Class III (cobalt) positives. Mr. McMaster has elected to take the settlement agreement that is offered by the AGCO for Class III positives, first violation. These positives are considered a 1st violation as Mr. McMaster was not notified of his 1st positive when he received the 2nd positive, March 6,2021 and March 7,2021.

Violation of AGCO rules 9.09 (b), 26.02.01, 26.02.02 and 26.02.03 (c). Full suspension of 20 days (March 24-April 12, 2021 inclusive) and a monetary penalty of \$1,000.

As per AGCO rule 18.08.01, purse money and driver/trainer fees shall be returned to the Association with 15 days for redistribution. Horses Tymal Houdini, ruling #1177392 and "Dontblvmejustwatch", ruling #1178115. Both horses disqualified as per AGCO rule 9.13.

Race Official Tom Miller is monitoring the races remotely this evening.

Race 2 – "Caught In A Dream" #1 (Travis Cullen) was distanced and qualifies for performance. Trainer Rene Bourassa. Vet-checked okay.

"Who Cut The Cheez" #1 (Colin Kelly), the 7th place finisher makes a break in stride.

"Bochneezba" #2 (Daryl Thiessen), the race winner was clear and down in to his lane. Mr. Kelly stated his horse was steering badly and tried to go up the inside of Mr. Thiessens horse. No placings.
