

Race 1, JCOF #1, J. Alderson, 3rd, on #5, Pierre Mailhot, 2nd into the clubhouse turn, upon review of upper pan and front tower camera angles, #5 is coming in slightly but the #1 does lean out as well. The claim of foul was disallowed. The Stewards also reviewed the start regarding #3, Oopsy, J. Crawford, 5th, upon review the #2 bore out and the #4 bore in at the start forcing Crawford to check, no placings required.

Race 2, Jockey claim of foul, #6 P. Mailhot,4th, on #5, K. Johnson 3rd, through the stretch, Mr. P. Mailhot advised that he thought the crop of K. Johnson made contact with his mount in the head area. Upon review of the upper pan and front tower camera angles, it is apparent that the crop of Johnson does come across and make contact with the #6 and #5 was subsequently disqualified from third position and placed 5th. K. Johnson issued a monetary penalty in the amount of \$200.00. TB Ruling #1923861.

Race 3, #4 Hi Ast Power off a step slow, rest ok

Race 4, reviewed run around the far turn with #5, M. Pinto 4th, and #4, H. Vanek, 6th, #4 does make it tight on the fence for #5, has to check. No placings necessary. Did speak with Vanek who explained the horse is very difficult to steer and wears a strong bit in tits mouth for that purpose.

Following the fourth race, at 2:18 PM, the power system went down, partially, we were unable to continue and delayed for 42 minutes.
