

Mr Cathcart and Candice Warwick were in and did receive the disclosure package. This horse was claimed by owner Glen Alderson.

New owner Glen Alderson and Trainer Anthony Alderson were contacted, and they did elect to return the horse under rule 12.32.01. Mr Cathcart was informed, and the transfer of the horse happened today. Ruling #2257615. The booker at Fort Erie has been informed that the claim has been voided.

Jockey Steve Jadoo was in with regards to Fort Erie incident report #23-016-FS. Mr Jadoo was found to be in violation of AGCO rule 15.09.01 and 15.09.01 J.

Monetary penalty of \$500 and a 2-day full suspension. The days will be July 17and 18 of 2023. Ruling #2257724.

A review was held with Rachel Slevinsky from Race 6 at Fort Erie on July 10. The placing of the horse Lets Run Teo from 1<sup>st</sup> to 3<sup>rd</sup> for interference in the stretch. We will follow up with a ruling.

Race 1: Reviewed the start. #4 Doodle Dandy broke outwardly, did receive a fair start.

Race 2: El Guero pulled up in the stretch, the horse was examined by track veterinarian.

**Race 3:** #1 Bound Lucky was scratched in error as a Vet scratch. The horse was allowed to race for purse money only.

Mark Lee Buchanan was issued an official urging warning for striking a horse more than 3 consecutive times.

Race was good.

Race 4: Clear

**Race 5:** The horse Zafeather got loose in the barn area at 3am in the morning on July9. A security report confirmed this and so a Steward scratch was given. Race was clear.

Race 6: #2 Jamaican Jump stumped at the start.

**Race 7:** #5 The Green Planet was a Vet scratch at the gate. The horse fell and unseated the rider (Sanchez). Rider was fine. Refund \$15,769

#8 Dazzling Diva pulled up after the first turn and was examined by the track Vet, the bride had broken.
