Race 1: Money Matters #1 did pop the gate. The horse never did leave the gate. Gate crew closed the doors and there were no issues. All horses received a fair start.

Race 2: Vet scratch at the gate of #5 Bocelli. The horse reared and dropped the rider K. Johnson and horse went down in the gate. Johnson was unhurt. Refund of \$9,067

Race 3: Clear

Race 4: Vet scratch of #1 Sneaky Rebel in the paddock. Refund of \$1,833
