- Inquiry – Reviewed the start of #5 Doctor Wu (Kirk Johnson), finished 1<sup>st</sup>. The back tower video shows the gate of #5 opens early. The pan video shows that #5 has broken through his gate before the other gates have fully opened. As a result, #5 was ruled to have received an unfair start and refunded as per AGCO Rule 16.12(b). #5 was also ruled a non-starter; finished 1<sup>st</sup> and placed 8<sup>th</sup> and subsequently disqualified. Refund \$25,001.
