Ruling Number SB ADMIN 16/2019

TORONTO, ONTARIO – June 13, 2019

**IN THE MATTER OF THE HORSE RACING LICENCE ACT, 2015;
S.O. 2015, c.38, Sched. 9;
AND IN THE MATTER OF GEORGE LARGE, LICENCE NO. K58012**

On February 9, 2019, the standardbred horse "JUSTSAYYOULOVEME" (freeze brand #6NM99 finished sixth (6th) in the tenth (11th) race at Flamboro Downs. "JUSTSAYYOULOVEME" is trained by George Large "LARGE".

On February 12, 2019 Racing Forensics Inc. reported that the blood sample with Test Tag number 331904022 contained TC02 with a value measured at 37.5 mmol/L.

On February 12, 2019, the Racing Officials matched Test Tag 331904022 to the sample taken from "JUSTSAYYOULOVEME", and notified LARGE of the positive test.

TAKE NOTICE that based on the above LARGE is found to have violated 22.38(a), 26.02.01, 26.02.02 and 26.02.03 (d) of the Rules of Standardbred Racing.

Accordingly, pursuant to the authority under 6.01, 6.04, 9.08.2 and 22.38.06 of the Rules of Standardbred Racing and Policy Directive 1-2018, LARGE is hereby fully suspended for FORTY-FIVE (45) days (May 27, 2019 to July 10, 2019, inclusive) and issued a monetary penalty of two thousand five hundred dollars (\$2,500).


In accordance with Alcohol, Gaming and Racing Standardbred Rule 18.08.01, "JUSTSAYYOULOVEME" is hereby declared disqualified for all purposes with the exception of Pari-Mutuel Wagering. The revised order of finish for Race 11 at Flamboro Downs on February 9, 2019 is as follows:

The following terms are added to LARGE's license: two years of probation commencing July 15, 2019 to July 14, 2021, inclusive), pursuant to Rule 6.01 (d) of the Rules of Standardbred Racing and Policy Directive No. 3-2008.

1. The Licensee shall keep the peace and be of good behaviour;
2. The Licensee shall allow Commission Inspectors access to his stabling area at any time to conduct unannounced random searches for illegal or non-therapeutic medications or drugs;
3. The Licensee shall allow commission inspectors to seize any illegal or non-therapeutic medications or drugs found at his stabling area;
4. The Licensee shall be subjected to the AGCO's Out of Competition Program; and
5. The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed by the AGCO Judges for any breach of the terms of their license.
