Races:

Race 1: Judges Inquiry: Halfway through the stretch #2 Presto Score (Ryan Holliday) bears out in the first over position and hooks the wheel of #5 Southwind Sandor (Michiel Vanderkemp). This action also causes interference to #6 P L Oliver (Travis Cullen) and #7 Remembering Shorty (Paul Mackenzie).

As a result of the interference: #2 Presto Score 2nd placed 7th, #3 Gambling Addiction 3rd placed 2nd, #4 Land Of Royalty 6th placed 5th, Southwind Sandor 4th placed 3rd, #6 P L Oliver 5th placed 4th and Remembering Shorty 7th placed 6th.

Interference given to #5, #6 and #7.

A three-day driving suspension was assessed to driver Ryan Holliday from September 2nd /21 to September 4th /21 inclusive. AGCO Rule 22.05.01(a)(h). Ruling #1311504.
