Ruling Number SB ADMIN 48/2019

TORONTO, ONTARIO – December 11, 2019

**IN THE MATTER OF THE HORSE RACING LICENCE ACT, 2015;
S.O. 2015, c.38, Sched. 9;
AND IN THE MATTER OF GINA BRAGAGNOLO, LICENCE NO. Y86275**

On September 15, 2019, the standardbred horse "ROSE RUN SLIDER" (freeze brand # 5M252) finished fifth (5th) in the ninth (9th) race at Rideau Carleton Raceway. "ROSE RUN SLIDER" is trained by GINA BRAGAGNOLO "BRAGAGNOLO".

On September 17, 2019 Racing Forensics Inc. reported that the blood sample with Test Tag number 451925818, contained TC02 with a value measured of 39.5 mmol/L.

TAKE NOTICE that based on the above BRAGAGNOLO is found to have violated 22.38(a), 26.02.01, 26.02.02 and 26.02.03 (d) of the Rules of Standardbred Racing.

Accordingly, pursuant to the authority under 6.01, 6.04, 9.08.02 and 22.38.06 of the Rules of Standardbred Racing and Policy Directive 1-2018, BRAGAGNOLO is hereby fully suspended for **FOURTY-FIVE (45) days** (December 11, 2019 to January 24, 2020, inclusive) and issued a monetary penalty of two thousand five hundred dollars (\$2,500).

In accordance with Alcohol, Gaming and Racing Standardbred Rule 18.08.01, ROSE RUN SLIDER is hereby declared disqualified for all purposes, with the exception of Pari-Mutuel Wagering. Purse money to be returned for re-distribution. The revised order of finish for Race 9 at Rideau Carleton Raceway on September 15, 2019 is as follows:

ROSE RUN SLIDER - disqualified

The following terms are added to BRAGAGNOLO's license: two years of probation commencing (January 25, 2020 to January 24, 2022, inclusive), pursuant to Rule 6.01 (d) of the Rules of Standardbred Racing and Policy Directive No. 3-2008

1. The Licensee shall keep the peace and be of good behaviour;
2. The Licensee shall allow Commission Inspectors access to his stabling area at any time to conduct unannounced random searches for illegal or non-therapeutic medications or drugs;
3. The Licensee shall allow commission inspectors to seize any illegal or non-therapeutic medications or drugs found at his stabling area;
4. The Licensee shall be subjected to the AGCO's Out of Competition Program; and
5. The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed by the AGCO Racing Officials for any breach of the terms of their license.
