Two horses of Trainer Jeffery Williamson R3 #1 Captain Godro and R4 #6 Wheres No No were involved in a trailer accident enroute to the track. The vet at the track examined them #6 Wheres No No is a vet scratch lame and the other horse is a transportation scratch. Both horses were going to Guelph for examination.
