IN THE MATTER OF THE HORSE RACING LICENCE ACT, 2015, S.O. 2015, c.38, Sched. 9; AND IN THE MATTER OF HERBERT HOLLAND

On August 7, 2021, the standardbred horse "THE GREEK FREAK" (tattoo number 6R422) finished first (1st) in the tenth (10th) race at Mohawk Park Raceway. "THE GREEK FREAK" is trained by Herbert Holland "HOLLAND".

On August 10, 2021, Racing Forensics Inc. reported that the blood sample with Test Tag number 532121920, contained TC02 with a value measured at 40.0 mmol/L.

TAKE NOTICE that based on the above HOLLAND is found to have violated 22.38 (a), 26.02.01, 26.02.02 and 26.02.03 (d) of the Rules of Standardbred Racing.

Accordingly, in accordance with Rules 6.01, 6.04, 9.08.2, 22.38.06 of the Rules of Standardbred Racing ("Rules"), and Policy Directive 1-2018, HOLLAND is hereby fully suspended for NINETY days (90) (November 17, 2021 to February 15, 2022, inclusive) and issued a monetary penalty of five thousand (\$5,000) dollars.

TAKE NOTICE that all horses owned in whole or in part are suspended and are not eligible to race during the suspension period. All horses may with the consent of the AGCO Racing Officials be released to another trainer in accordance with Rules 6.13.01 and 26.08. All purse monies shall be returned for redistribution. In accordance with Rules 9.13 and 18.08.01, "THE GREEK FREAK" is hereby declared unplaced for all purposes, with the exception of Pari-Mutuel Wagering. The revised order of finish for Race 10 at Mohawk Park Raceway on August 7, 2021 is as follows:

#5 THE GREEK FREAK - disqualified

The following terms are added to HOLLAND's license: two years of probation commencing (February 16, 2022 to February 15, 2024, inclusive), pursuant to Rule 6.01 (d) of the Rules of Standardbred Racing and Policy Directive No. 3-2008.

- 1. The Licensee is required to complete the AGCO Equine Medication Use and Awareness Program before reinstatement;
- 2. The Licensee shall keep the peace and be of good behaviour;
- 3. The Licensee shall allow Commission Inspectors access to his stabling area at any time to conduct unannounced random searches for illegal or non-therapeutic medications or drugs;
- 4. The Licensee shall allow commission inspectors to seize any illegal or non-therapeutic medications or drugs found at his stabling area;
- 5. The Licensee shall be subjected to the AGCO's Out of Competition Program; and
- 6. The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed by the AGCO Judges for any breach of the terms of their license.
