IN THE MATTER OF THE HORSE RACING LICENCE ACT, 2015. S.O. 2015, c.38, Sched. 9; AND IN THE MATTER OF Kevin Joseph ENMAN

On November 3, 2022, the standardbred horse "LAND OF ROYALTY" (tattoo number 8RN33) finished third (3rd) in the second (2nd) race at Woodbine Mohawk Park Raceway. LAND OF ROYALTY is trained by KEVIN ENMAN "ENMAN" LAND OF ROYALTY was in the EIPH Program.

On November 6, 2022, Racing Forensics Inc. reported that the blood sample with Test Tag number 532230703, contained TC02 with a value measured at 39.1 mmol/L.

TAKE NOTICE that based on the above ENMAN is found to have violated 22.38(b), 26.02.01, 26.02.02 and 26.02.03 (d) of the Rules of Standardbred Racing.

In accordance with Rules 4.02(i), 6.04 and 22.38.06 of the Rules of Standardbred Racing and Policy Directive 1-2018, ENMAN is hereby fully suspended for 45 days (March 25, 2023 to May 8 2023, inclusive) and issued a monetary penalty of two thousand, five hundred dollars (\$2,500) dollars.

TAKE NOTICE that all horses owned in whole or in part are suspended and are not eligible to race during the suspension period. All horses may with the consent of the AGCO Racing Officials be released to another trainer in accordance with Rules 6.13.01 and 26.08. All purse monies shall be returned for redistribution. In accordance with Rules 9.13 and 18.08.01, LAND OF ROYALTY is hereby declared unplaced for all purposes, with the exception of Pari-Mutuel Wagering. The revised order of finish for Race 2 at Woodbine Mohawk Park Raceway on November 3, 2022 is as follows:

#1 LAND OF ROYALTY - disqualified The following terms are added to ENMAN license: two years of probation commencing (May 9, 2023 to May 8, 2025, inclusive), pursuant to Rule 4.02(i), and 6.04 of the Rules of Standardbred Racing and Policy Directive No. 3-2008.

- 1. The Licensee is required to complete the AGCO Equine Medication Use and Awareness Program before reinstatement;
- 2. The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed by the AGCO Race Officials for any breach of the terms of their license.
