AMENDED Ruling Number SB ADMIN 40/2018

TORONTO, ONTARIO - September 26, 2018

IN THE MATTER OF THE HORSE RACING LICENCE ACT. 2015; S.O. 2015, c.38, Sched. 9; AND IN THE MATTER OF LOUIE EFTIMIADIS, LICENCE NO. R35320

On July 27, 2018, Maxxam Analytics Inc. reported that the blood sample with Test Tag 5318195 304, EIPH revealed Furosemide Quantified at 139 ng/ml, a Class V violation. The sample was obtained from the Standardbred Horse "DONTBRUISECARRIE" (freeze brand #7KS09) which finished second (2nd) in the first (1st) race on July 14, 2018, at Mohawk Raceway. DONTBRUISECARRIE is trained by Louie Eftimiadis "Eftimiadis".

Pursuant to Ruling SB 49412 Eftimiadis is currently on probation for a prior positive test for TC02.

TAKE NOTICE that based on the above Eftimiadis is found to have violated 9.09 (a), (b), 26.02.01, 26.02.02 and 26.02.03 (c) of the Rules of Standardbred Racing and Policy Directive 3-2008. Accordingly, in accordance with Rules 6.01, 6.04, 9.08.2 and Policy Directive 1-2008, Eftimiadis is hereby issued a monetary penalty of one thousand (\$1,000) dollars.

In accordance with Alcohol, Gaming and Racing Standardbred Rule 18.08.03, *DONTBRUISECARRIE* is hereby declared unplaced for all purposes with the exception of Pari-Mutuel Wagering. The revised order of finish for Race 1 at Mohawk on July 14, 2018 is as follows:

The following terms are added to Eftimiadis' license: two years of probation commencing June 12, 2019 to June 11, 2021 in addition to the probation from Ruling SB 49412, pursuant to Rule 6.01 (d) of the Rules of Standardbred Racing and Policy Directive No. 3-2008.

- 1. The Licensee shall keep the peace and be of good behaviour;
- 2. The Licensee shall allow Commission Inspectors access to his stabling area at any time to conduct unannounced random searches for illegal or non-therapeutic medications or drugs;
- 3. The Licensee shall allow commission inspectors to seize any illegal or non-therapeutic medications or drugs found at his stabling area;
- 4. The Licensee shall be subjected to the AGCO's Out of Competition Program; and
- 5. The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed by the AGCO Judges for any breach of the terms of their license.
