Ruling Number SB ADMIN 37/2019

TORONTO, ONTARIO – December 24, 2019

**IN THE MATTER OF THE HORSE RACING LICENCE ACT, 2015;
S.O. 2015, c.38, Sched. 9;
AND IN THE MATTER OF MARY PAULIC, LICENCE NO. P83902**

On October 6, 2019, the standardbred horse "DOMINUM DEO" (freeze brand # 9J140) finished NINTH (9TH) in the tenth (10th) race at Flamboro Downs Raceway. "DOMINUM DEO" is trained by MARY PAULIC "PAULIC".

On October 8, 2019 Racing Forensics Inc. reported that the blood sample with Test Tag number 331927919, contained TC02 with a value measured of 38.0 mmol/L.

TAKE NOTICE that based on the above PAULIC is found to have violated 22.38(a), 26.02.01, 26.02.02 and 26.02.03 (d) of the Rules of Standardbred Racing.

Accordingly, pursuant to the authority under 6.01, 6.04, 9.08.2 and 22.38.06 of the Rules of Standardbred Racing and Policy Directive 1-2018, PAULIC is hereby fully suspended for NINETY (90) days (December 24, 2019 to March 22, 2020 inclusive) and issued a monetary penalty of five thousand dollars (\$5,000).

In accordance with Alcohol, Gaming and Racing Standardbred Rule 18.08.01, "DOMINUM DEO" is hereby declared disqualified for all purposes, with the exception of Pari-Mutuel Wagering. The revised order of finish for Race 10 at Flamboro Downs Raceway on October 6, 2019 is as follows:

DOMINUM DEO L - disqualified

The following terms are added to PAULIC's license: two years of probation commencing (March 23, 2020 to March 22, 2022, inclusive), pursuant to Rule 6.01 (d) of the Rules of Standardbred Racing and Policy Directive No. 3-2008.

1. The Licensee shall keep the peace and be of good behaviour;
2. The Licensee shall allow Commission Inspectors access to his stabling area at any time to conduct unannounced random searches for illegal or non-therapeutic medications or drugs;
3. The Licensee shall allow commission inspectors to seize any illegal or non-therapeutic medications or drugs found at his stabling area;
4. The Licensee shall be subjected to the AGCO's Out of Competition Program; and
5. The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed by the AGCO Judges for any breach of the terms of their license.
