**IN THE MATTER OF THE *HORSE RACING LICENCE ACT, 2015*,
S.O. 2015, c.38, Sched. 9;
AND IN THE MATTER OF R GREGG MCNAIR**

On June 24, 2020 Maxxam Analytics Inc. reported that the urine sample with Test Tag 53 20157 007, revealed a positive reading for the Class 4 drug Cetirizine. The sample was obtained from the Standardbred Horse "BEACH SPORTS" (freeze brand #8RM964) which finished second (2nd) in the sixth (6th) race on June 5, 2020, at Mohawk Raceway. BEACH SPORTS is trained by R. GREGG MCNAIR "MCNAIR".

On June 12, 2018 MCNAIR was issued Ruling Number SB 49552 for a Class 4 positive Test;

TAKE NOTICE that based on the above MCNAIR is found to have violated 9.09 (a), (b), 26.02.01, 26.02.02 and 26.02.03 (c) of the Rules of Standardbred Racing.

Further, it was found that MCNAIR had the 3 improperly labelled bottles of dexamethasone contrary to Rule 6.46.01. Accordingly, pursuant to Rules 6.04, 9.08.02, and Policy Directive 1-2018 MCNAIR is hereby fully suspended for thirty (30) days (October 23, 2020 – November 21, 2020) and issued a monetary penalty of four thousand, five hundred dollars (\$4,500) dollars.

In accordance with Alcohol, Gaming and Racing Standardbred Rule 18.08.03, BEACH SPORTS is hereby declared unplaced for all purposes with the exception of Pari-Mutuel Wagering. The revised order of finish for Race 6 at Mohawk on June 5, 2020 is as follows:

The following terms are added to MCNAIR' license: two years of probation commencing November 22, 2020 – November 21, 2022, pursuant to Rule 6.01 (d) of the Rules of Standardbred Racing and Policy Directive No. 3-2008.

1. The Licensee shall keep the peace and be of good behaviour;
2. The Licensee shall allow Commission Inspectors access to his stabling area at any time to conduct unannounced random searches for illegal or non-therapeutic medications or drugs;
3. The Licensee shall allow commission inspectors to seize any illegal or non-therapeutic medications or drugs found at his stabling area;
4. The Licensee shall be subjected to the AGCO's Out of Competition Program; and
5. The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed by the AGCO Judges for any breach of the terms of their license.
