Race 2: **Inquiry:** #6 Ezra (J.Macdonald), finished 2nd, went inside one pylon in deep stretch attempting to pass race winner #4 Shes Got Pizzaz on the inside. No placings needed as #6 Ezra was already ahead of 3rd place finisher, #8 Bettina Hanover when Macdonald attempted to pass on the inside without sufficient clearance.
