## Office:

A paddock meeting has been scheduled for Thursday December 28 (6:00 PM) to review Standardbred rules 6.54.01 and 6.54.02 which come into effect on January 1, 2024. These rules relate to the out of competition testing of horses after a qualifier. This testing will be looking for any Analgesic, Corticosteroid, Anti-inflammatory, NSAID or local anesthetic. Also, substances that belong to the classes of drug that do not have an elimination guideline. As a reminder, horses qualifying to come off the long-term vet's list will continue to be tested, as they have been since June of 2023.

Trainer Meg Crone was assessed a \$100 monetary penalty for causing a stable error scratch with the horse Powder Play from Race 5 this evening. AGCO Rule 20.03.01(i). Ruling #2476838.

James Macdonald was assessed a \$300 monetary penalty for acting unprofessionally towards the Commission Veterinarian before Race #3 on December 11<sup>th</sup>, 2023. AGCO Rule 6.20(b). Ruling #2476866.
