Inquiry #2 Reviewed the break by #2 Don't Dilly Dally (Roy) at the <sup>3</sup>/<sub>4</sub> pole. The trailing horses #3 Just Plain Needy (McNair) and #4 Red Dirt Fuloheart (J. MacDonald) did go down in a chain reaction and unseated both drivers. #2 finished 5<sup>th</sup> and was placed 7<sup>th</sup> and disqualified for causing interference. Horses #6 Riot, #7 Ready to Rumble, #8 Sunny Bo and #9 Quizzer were charted with interferences also.

Driver J. MacDonald was excused from the balance of his drives and Driver D. McNair was assessed and was cleared to continue his drives.

Horses Just Plain Needy was examined by the track Vet and was found to have minor abrasions, and the horse Red Dirt Fuloheart was found to be in good condition.

The horse Butterfly Hanover finished distanced and must qualify. Tr, K. Reibeling.

Race 3

Recall #10 Arrakis came to the gate in the wrong position, driver McNair could not keep the horse in the trailing position. Late Judges scratch of #10 Arrakis (unmanageable). Ref \$64,969.
