IN THE MATTER OF THE HORSE RACING LICENCE ACT, 2015. S.O. 2015, c.38, Sched. 9; AND IN THE MATTER OF ONDREJ GOIS

On July 24, 2021, the Standardbred horse "McSINNER MAN" (tattoo number 3L685) finished seventh (7th) in the tenth (10th) race at Kawartha Downs Raceway. "MCSINNER MAN" is trained by Ondrej (Licence #HPY72754) Gois "GOIS".

On July 27, 2021, Racing Forensics Inc. reported that the blood sample with Test Tag number 422120519, contained TC02 with a value measured at 39.5 mmol/L.

TAKE NOTICE that based on the above GOIS is found to have violated 22.38 (a), 26.02.01, 26.02.02 and 26.02.03 (d) of the Rules of Standardbred Racing.

Accordingly, in accordance with Rules 6.04, 9.08.02, 22.38.06 of the Rules of Standardbred Racing ("Rules"), and Policy Directive 1-2018, GOIS is hereby fully suspended for ONE HUNDRED AND TWENTY days (120) (November 9, 2021 to March 9, 2022, inclusive) and issued a monetary penalty of FIVE THOUSAND DOLLARDS (\$5000) dollars.

TAKE NOTICE that all horses owned in whole or in part are suspended and are not eligible to race during the suspension period. All horses may with the consent of the AGCO Racing Officials be released to another trainer in accordance with Rules 6.13.01 and 26.08. All purse monies shall be returned for redistribution. In accordance with Rules 9.13 and 18.08.01, "MCSINNER MAN" is hereby declared unplaced for all purposes, with the exception of Pari-Mutuel Wagering. The revised order of finish for Race 10 at Kawartha Downs Raceway on July 24, 2021 is as follows:

1st #6 Shadow of Lindy 2nd #5 Woodmere Rollnpop 3rd #7 Dreamy Fella 4th #2 Big Journey 5th #4 Lively Rocket 6th #3 Leader Tonight

#1 MCSINNER MAN - disqualified

The following terms are added to GOIS's license: two years of probation commencing (March 10, 2022, to March 9, 2024, inclusive), pursuant to Rule 6.04 of the Rules of Standardbred Racing and Policy Directive No. 3-2008.

- 1. The Licensee is required to complete the AGCO Equine Medication Use and Awareness Program before reinstatement;
- 2. The Licensee shall keep the peace and be of good behaviour;
- 3. The Licensee shall allow Commission Inspectors access to his stabling area at any time to conduct unannounced random searches for illegal or non-therapeutic medications or drugs;
- 4. The Licensee shall allow commission inspectors to seize any illegal or non-therapeutic medications or drugs found at his stabling area;
- 5. The Licensee shall be subjected to the AGCO's Out of Competition Program; and
- 6. The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed by the AGCO Judges for any breach of the terms of their license.
