

Office:

- The Stewards held a virtual review with Jockey Miguel Nicholls concerning his urging in race two on Wednesday. Mr. Nicholls was reminded of the urging rules. Mr. Nicholls was also reminded about being punctual when the Stewards request a review with him.
- Test strips were utilized in races two and three.

Race 1:

- Stewards Inquiry reviewed the break at the start by #4 Hanover Hill Dashing (Cheyenne Kerr), (finished third and was placed fifth) and #5 Kitsawinner (Ten Harriott), (finished fifth and was placed fourth). #4 breaks awkwardly and stumbles into the path of the #5 causing the #5 to avoid the #4. The horses were a long nose apart at the wire. The Stewards determined that #4 caused interference to #5. #4 finished third and was placed fifth for causing interference to #5. There is no review required with Jockey Cheyenne Kerr due to the awkward nature of how her horse broke.

Race 2:

 Prior to the race Jockey Cheyenne Kerr was granted permission by the Stewards to carry a crop.

Race 3:

Stewards Inquiry reviewed the start by #2 Fly Belle Cartel (Ramiro Castillo), (did not finish). The Stewards determined that #2 was pulling on the flipping halter and this was the reason the doors did not open. As per AGCO QH rule 6.46, this horse was deemed to have received a fair start.

- The winner of the race (#3 Zoxtobeyou) was reported as being fractious in the test area. The Stewards spoke to Trainer Janet Grice and informed her that it is her responsibility to ensure that the horse behaves in the test area in the future.

Race 4:

#5 Senor Pagrana (Ramiro Castillo), (finished fifth) pushed through the doors just prior to the start and unseated the Jockey. The horse was under the Assistant Starters control. The horse was examined by the Association Vet and reloaded.

Race 5:

- #2 Countrys Comin Bac (Cassandra Jeschke), (finished fourth) stumbled on the break.
- The Stewards reviewed #4 Countryfried Chicken (Ed Walton), (finished fifth) who was visibly lugging in. #4 crowded the #3 Maryland Magic (Ricardo Moreno), (finished sixth) into #2 Countrys Comin Bac (Cassandra Jeschke), (finished fourth). #2 ends up on the heels of #1 Had to be Ivory (Josh Scott), (finished first). The Stewards spoke to Jockey Ed Walton who stated that the horse was lugging in badly. No placings were required as #2 finished ahead of #4. There is no review required with Jockey Ed Walton.

Race 6:

- #5 On Pointe (Ed Walton), (finished seventh) broke in the air.
