Office:

- The Stewards held a review with Jockey Max Badal concerning his urging in race eight last week (August 25, 2021) while riding the horse, Phil Jefferson. Mr. Badal was found to be in violation of AGCO rule 9.27.05 (b) (*urging, excessive*) and is subject to a monetary penalty of \$200 for his first offence in a one-year period. Ruling #1312840
- The Stewards held a review with Jockey Ismael Mosqueira concerning the giving two calls in race three today. Mr. Mosqueira was found to be in violation 15.09.01 (j) (*acceptable business practices*) and is subject to a \$100 monetary penalty. Ruling #1312930
- The Stewards spoke to Race Secretary Allen Hadley and Trainer Jason Pascoe about AGCO rule 9.21 (*the naming of riders at time of entry*).

**Race 1:**

- The electronic timer malfunctioned; hand times were utilized.

**Race 2:**

- #3 Rapter (Josh Scott), (finished ninth) broke in the air.

**Race 3:**

- #2 Countryfried Chicken (Helen Vanek), (finished eighth) broke awkwardly.

**Race 4:**

- #3 Perrier Special (Tony Phillips), (finished first) showed symptoms of epistaxis and was placed on the Veterinarians list after the race.

**Race 5:**

- The Stewards reviewed the break between #2 Jazz Steppin (Rachael Isaccs), (finished fourth) and #3 Pegasos Two Underpar (Josh Scott), (finished third). #3 stumbles badly on the break and comes down to #2. #2 is never compromised. No placings were necessary.

**Race 6:**

- #2 Summers Grace (trained by Chantelle Bourgeois) was a late scratch in the paddock by the Association Veterinarian. It was announced that there will be no triactor wagering on this race due to the late scratch.
- Stewards' inquiry and Jockey claim of foul #4 Upandover (Cory Spataro), (finished second and was placed first) on #5 Signature Eyes (Tony Phillips), (finished first and was placed second). #5 goes down to #4 midway through the stretch and #5 interferes with #4, turning the #4 outward. #5 Signature Eyes finished first and was placed second for causing interference to #4 Upandover.

The Stewards will be holding a review next week with Jockey Tony Phillips concerning his placing in this race.

**Race 7:**

- Prior to the race seven the Stewards excused Jockey Ismael Mosqueira from his last three mounts.
- The Stewards approved a late rider change for #1 Whos Hot Now from Ismael Mosqueira to Ricardo Moreno.
- Inquiry, Jockeys claim of foul #3 Winning Okie (Max Badal), (finished sixth) on #1 Who Hot Now (Ricardo Moreno), (finished fourth). #3 is away slow, #1 comes outward as #3 is coming over behind the #1 into the two path. #3 is never compromised. The Jockey claim of foul was disallowed.
