- #1 Perrier Special (Rachael Isaacs) was fractious in the gate and was subsequently scratched by the Association Veterinarian.
- Stewards Inquiry reviewed the break by #6 Whos Hot Now (Ismael Eluid Mosqueira), (finished third) and #7 Kool Kastillo (Ramiro Sanchez Castillo), (did not finish).

#6 and #7 come together on the break. The Jockey of #7 (Ramiro) broke a stirrup and was unseated. No changes are required.

- Second inquiry. Trainers claim of foul #2 Tres On Fire (Rachael Isaacs), (finished fourth placed third) on #4 Jess A Deal (Ismael Eluid Mosqueira), (fifth placed fourth)
- Both inquiries were the result of the same incident. #4 is away slowly as #5 continues to come inward pushing the #4 into the #2. This put #2 on the heels of the #1 Shaken (Cassandra Jeschke), (finished third placed second).
